The second scholarly case report- Multiple Mandibular Supernumerary Supplemental premolars- a Non-syndromic Bilateral Presentation in a Female Libyan Patient- is from Sebha, Libya. Supplemental tooth are tooth that resemble a tooth of normal series. The presence of bilateral supernumerary premolars in absence of any associated syndromes or systemic conditions is extremely rare. And this rare phenomenon is presented in this second case report in this issue.

The third, clinically quite interesting and scholarly, case report- Reattachment of Fractured Anterior Tooth- a Conservative Approach- is from Davangere, India. It demonstrates how the reattachment of fractured tooth fragment is the best method of restoring the functions, esthetics and biological properties of the tooth structure rather than prosthetic and artificial looking restorations.

Unusual Calculus Mass in Floor of Mouth: a Case Report is from India and describes the presentation of a huge mass of calculus in the floor of the mouth.

As the primary aim of the Case Reports in Odontology is to generate and disseminate new knowledge on various disciplines in Dentistry, we provide immediate open access to its all content to the global academic and research fraternity to help in catering to the research and academic needs of those who are in search of knowledge.

To sum up, I take this opportunity to invite the researchers to submit their case reports to the next issue of the Case Reports in Odontology in June, 2015, by adhering to the policies and manuscript guidelines of the journal, as due to the editorial and review policies, we could not include many case reports of our colleagues around the globe in this issue who showed their interest in Case Reports in Odontology.
